## Worked All Virginia Award

**Sponsor:** Rappahannock Valley Amateur Radio Club, Fredericksburg, Virginia

**Object:** To promote amateur radio activity within the state of Virginia, and to encourage radio contacts with Virginia amateurs.

Available to Radio Amateurs worldwide who have made 2-way amateur radio contact with at least 50 Virginia counties or Independent Cities. Contacts can be made from any QTH.

The Basic Award is attained by contacting 50 counties or Independent Cities.

The Golden Endorsement requires contact with all 95 counties or an Independent City bordering the county claimed. If using the Independent City to claim credit for working a county, you may use that Independent City credit for only ONE county (for example, if you work a station in Richmond, you can't claim credit for working Henrico County AND Chesterfield County).

The Virginia Presidents Endorsement requires communication with a station in each of the 95 counties (not a bordering Independent City) AND each of the Independent Cities.

All modes and amateur frequencies are eligible for use in attaining this award. No repeater, phone patch, or cross-mode QSO's allowed.

Fees: \$5.00 (U.S.) for the Basic Award to cover cost of printing and mailing. A self-addressed stamped envelope (SASE) is required to get the endorsement stickers.

Applications for the Worked All Virginia (WAV) Award certificate must be submitted on the WAV Application form along with the Counties and Independent Cities record sheet showing callsign and county of station worked, date, time (UTC), band, and mode.

The WAV Award Managers reserve the right to spot check any QSO's for validity by requesting QSL cards or contacting the listed station to confirm the QSO.

## NCVEC Question Pool Committee Removes Three Questions From Use

Three ARRL VEC Exam Booklets Repair Required

### NCVEC Question Pool Committee Removes Three Questions from Use

The National Conference of Volunteer Examiner Coordinators ([NCVEC](#)) Question Pool Committee (QPC) has removed two questions from the General Class question pool and one question from the Extra Class pool from use.

Due to recently published FCC rule changes affecting the 60 meter band (see previous [ARRL News](#) story), General Class questions G1A04 and G1C09 are no longer valid and must be removed from use on examinations. Extra Class question E4D05 must also be removed because it contains more than one correct answer. All affected questions should be removed from examinations as soon as possible.


Updated General Class question pool files, including the errata and new information, have been posted to the NCVEC General Class question pool web page at [www.ncvec.org/index.php/2023-2027-general-question-pool-release](http://www.ncvec.org/index.php/2023-2027-general-question-pool-release). The current Element 3 General question pool became effective on July 1, 2023, and it is valid through June 30, 2027.

Updated question pool files have also been posted to the NCVEC Extra Class question pool web page at [www.ncvec.org/index.php/2024-2028-extra-class-question-pool-release](http://www.ncvec.org/index.php/2024-2028-extra-class-question-pool-release). The current Element 4 Extra question pool became effective on July 1, 2024, and it is valid through June 30, 2028.

The [ARRL VEC](#) advises the amateur radio community, and particularly Volunteer Examiners (VEs), to regularly check the NCVEC website at [www.ncvec.org](http://www.ncvec.org) for updates to the question pools, which may include errata and withdrawn questions.

### Action Required: Repair Three ARRL VEC Exam Booklets

The Question Pool Committee (QPC) has withdrawn General Class questions G1A04 and G1C09, and Extra Class question E4D05. These withdrawals affect three ARRL VEC–issued exam booklets. VE teams must update the affected booklets, as well as any exams created or printed locally that include these questions.



Please review the required actions below for teams still using ARRL VEC–supplied printed booklets.

Affected Booklets and Required Updates:

- General Exam – Version 3-6-2023: Replace Question 2
- General Exam – Version 3-10-2023: Replace Question 13
- Extra Exam – Version 4-1-2024: Replace Question 30

Instructions for Booklet Repair:

- Do NOT discard these booklets. Patch the withdrawn questions using the official replacement text provided by ARRL VEC.
- The three patch documents (dated Feb. 2026) are available on the [Exam Booklets](#) webpage.
- Cut out the replacement question and affix it over the original using tape or glue. The replacement will fully cover the withdrawn question.
- Answer positions remain unchanged, so grading templates and answer keys will continue to align properly.

For Teams Printing Their Own Exams in the Field:

You must either --

- Print new exams, or
- Replace the questions on affected exams.

If replacing the question, ensure the correct answer position matches the original answer key to maintain grading accuracy.
